Highlights of the Regional Board Meeting–Aug 28, 2000

Support for larger local calling area

The Regional Board gave its support to a recommendation prepared by the Economic Development Commission Board and Telus. The Board has agreed to a resolution requesting Telus to develop and submit a community initiated application to the CRTC which supports the expansion of a local calling area. This will allow all customers within the Central Okanagan Region to call one another without long distance charges. The Board had previously reviewed this submission at the July 10, 2000 Board Meeting and requested a recommendation from the Economic Development Commission, as well as from each Municipal Council. The City of Kelowna and the District of Peachland have submitted support in writing for expanding the local calling area, as has the Economic Development Commission Board.
