Highlights of the Regional Board Meeting - Mar. 6, 2000

Central Okanagan Regional Hospital District Meets

Murray Ramsden, Administrator and Ellen McRae Chairperson for the Okanagan Similkameen Health Region were invited to provide the Regional Board with an update on future plans for the health region. Population projections show that the Okanagan continues to be a popular retirement destination. By the year 2009, it is estimated that 26% of the population will be over 65 years of age. In order to meet the health care requirements of this growing segment of the population, 650 new long term beds are needed. A new tower is also in the plans for Kelowna General Hospital to house heart surgery patients. Mr. Ramsden stressed the need for an infusion of funds and innovative partnerships with private sector care providers to meet the projected demand for health care facilities.

The Regional Hospital District Board is comprised of the same members as the Regional District Board and meets as required on decisions pertaining to capital funding of the Regional Hospital District.

Community Arts Centre seeks funding

The Regional Board is seeking more information before granting a request to provide additional funding for the Community Arts Centre. Campaign Chair, Ken Thom and President Deborah Helf gave a presentation to the Board outlining the tremendous community support for this project. The Board was informed that close to \$6 million has been raised towards the goal of \$6.8 million. The City of Kelowna has already committed \$2.8 million, plus designation of the land and building. The Regional Electoral areas, Peachland and Lake Country are being asked to provide \$10,000/year for the next five years for a total of \$50,000 as their contribution towards the Community Arts Centre. Each area will give the request further review before making a final decision.

Support sought for Ecosystem

The Regional Board received correspondence from the Okanagan Basin Water Board regarding the possibility of an ecosystem based management approach for the Okanagan Valley. The Water Board is currently

approaching the Federal and Provincial governments to develop a partnership to work towards an ecosystem-based approach to managing water and air resources while at the same time protecting the habitat in the Valley. The Federal Government has funded similar systems in the past and research is currently underway to see if this would be feasible for the area. Board Chair, Robert Hobson will be gathering information on this issue from senior government as part of his position on the UBCM Environment Committee.

Approval sought for Cst. Neil Bruce Middle School sports field lease agreement

In accordance with the Municipal Act, the Regional District gave the first three readings to the Bylaw for the lease agreement and counter petition for the Neil Bruce Sports Fields. The assent of the electors is required as the lease agreement extends for more than five years for this joint use agreement involving many other community partners. The Act requires that counter petitions be made available for distribution to each person that requests one. Based on 13,649

potential electors in the area, if 5% petition against the bylaw, a referendum would be required. If more than 50% petition against, the bylaw cannot proceed. The deadline for counter petition signatures is Tuesday, April 11, 2000 at 4:00 pm.
